Vendors fees:

Food Vendors: \$500
Non-Food Vendors: \$300
Information Vendors: \$150
Food Truck: \$700

Mandatory Refundable fees:

Food Vendors: \$200
Non-Food Vendors: \$100
Information Vendors: \$50
Food Truck: \$200

- **Selling Vendors (Food & Non-food):**
Event vendors are responsible for obtaining a special event vendor permit from the Business License Department. The current fees are \$50.37 per day. The City of Long Beach Special Events Application can be found on the City of Long Beach website <http://longbeach.gov/finance/media-library/documents/business-info/business-licenses/special-event-vendor-application/>
- **Temporary Food Facility (TFF):**
Vendors will need to purchase a temporary health permit from the City of Long Beach Environmental Health Services. Temporary Food Facility vendors will also need to pay a **FLAT FEE** of **\$200** for 3-compartment sink and water. City health requirements and application can be found at the following link: <http://longbeach.gov/health/inspections-and-reporting/forms/environmental-health/>
- **Open-Flame firepit/Barbeque:**
If you cook on an open-flare firepit, you will need to pay a **FLAT FEE** of **\$50**.
- **Drinks:**
Tafesilafa'i Booth will be the **ONLY** booth to sell drinks (water, sodas & tropical drinks) on **BOTH DAYS**.
- **Power:**
There will be a fee of \$75 for power. We also charge \$200 for overnight power.
- **Merchandise/Arts and Crafts Vendors:**
Tafesilafa'i **WILL NOT** collect a percentage fee or commission on any sales; all proceeds go to the vendors. All vendors shall be responsible for collecting and reporting taxes and are required to possess their own State Board of Equalization Seller's Permit. Your original seller's license **MUST** be displayed in your booth. A copy of your seller's license **MUST** be provided along with your Booth Application.
- **Parking:**
Tafesilafa'i will provide each vendor with a **SINGLE PARKING PASS (ONE VEHICLE FOR EVENT DAYS ONLY!)** for each 10 x 10 space rented.

Please note that we are **ONLY** providing the space. You are **required** to **BRING YOUR OWN** 10 x 10 tent, tables and chairs.

We remind vendors that our community is very family-oriented. We **DO NOT ALLOW** any drug-related items or items of a risqué nature sold at our events. Tafesilafa'i reserves the right to prohibit the sale of any item and may close down your booth.
